

Terms of Service: This vehicle is to be used by professional, hired operators in commercial applications. It is primarily designed for the transport of implements used in such applications. This machine allows for the safe transport of an operator and one passenger in the identified seats. The bed of this machine is not suitable for any riders. This machine is designed primarily as an off-road machine and is not intended for extensive use on public roads. When using the machine on public roads, follow all traffic regulations and used additional accessories that may be required by law, such as lights, turn signals, and others as required.

The Lessee shall read all information in the specified owner's or operator's manual carefully to learn how to operate and maintain the product properly and to avoid injury and product damage. The Lessee and its authorized operators are responsible for operating and maintaining the product properly and safely.

It is the responsibility of the Lessee to carefully review all instruction(s) on operation, recommended maintenance schedules, procedures, and checklists in the operator's manual prior to operation of the equipment. In addition, the lessee is responsible to review all warnings, cautions, labels, and/or potential hazards listed in the operator's manual prior to operation of the equipment.

- This machine is designed to carry the operator and one passenger only. Operator and passenger must remain seated whenever the machine is in motion. Never carry passengers in the cargo bed or other parts of the machine.
- Never allow children or people unfamiliar with these instructions to use or service the vehicle. Local regulations may restrict the age of the operator.
- Always be aware of bystanders and other surroundings.
- Always wear substantial shoes. Do not wear loose-fitting clothing, tie back long hair, and do not wear jewelry. Wearing safety glasses, safety shoes, and long pants are required by some local safety and insurance regulations.
- Keep in mind that the operator or user is responsible for accidents or hazards occurring to other people or their property.
- The Lessee is responsible for training authorized additional users.
- Never make adjustments to machine, remove fuel cap or add fuel with the engine running. Allow engine to cool before refueling. Never overfill the fuel tank or refuel the machine indoors.
- Never store the machine or fuel container where there is an open flame, spark, or pilot light such as on a water heater or on other appliances.
- Engine exhaust contains carbon monoxide, which is an odorless, deadly poison that can kill you. Do not operate the engine in a confined space where dangerous carbon monoxide fumes can collect.
- Before attempting to operate the machine, ensure the operator is familiar with the controls and knows how to shut of the engine quickly. Never operate when tired, ill, or under the influence of alcohol or drugs.
- Remember there is no such thing as a safe slope. To guard against overturning:
 - Never overload your machine.
 - Do not operate the machine on wet or excessively steep slopes.
 - Do not stop or start suddenly when going up or downhill.
 - Machine speeds should be kept low on slopes and during tight turns.
 - Stay alert for humps and hollows and other hidden hazards.
 - Do not turn sharply. Use care when reversing.
 - Never dump a loaded cargo bed while the machine is sideways on a hill.
- Never operate the machine with damaged guards, shields, or without safety protective devices in place.
- Disconnect battery before making any repairs. Disconnect the negative terminal first and the positive last. Reconnect positive first and negative last.
- This product is capable of amputating hands and feet and throwing objects. Keep hands and feet away from cutting units and other moving parts.
- Use of this product for purposes other than its intended use could prove dangerous to users and bystanders.
